____ You must provide the Veteran Services Coordinator with the 'change of schedule' form, 'course substitution' form, or any other supporting documents if you make any changes to your schedule or degree plan.

____ You must make satisfactory academic progress (2.0 GPA). If your GPA drops below a 2.0 the VA will be notified, this may affect future certifications for benefits.

____ It is **your** responsibility to check your email account weekly. You will be notified of any changes to your account, certifications, and Veteran Resources. Failure to do so may result in delayed certifications or missed deadlines.

____ It is recommended that you file the Free Application for Federal Student Aid (FAFSA).

____ By turning in your Request for VA Certification (RVAC) form each semester, you will not be dropped from your classes. If you decide to not attend class or officially withdraw after the semester has started, you will still be responsible for tuition and fees.

____ CH 1606, 1607, AND 30 You must certify your attendance on the last day of every month with the VA (instructions will be sent via email). You are responsible for paying books, tuition, and fees.

____ CH 35. You are responsible for paying for books, tuition, and fees.

____ CH. 33 You are responsible for paying for books (you will receive a book stipend from the VA).
