High School Senior Business Scholarship:

- Based on need and merit
- \$500 per semester
- Renewable for up to 3 consecutive semesters (fall/spring only) for a maximum award amount of \$2,000.00
- Will be awarded at the beginning of the Fall 2016 semester after requirements have been met and verified by the Business Division Chair
- Number of awards: 1-2
- Award will be announced by May 1st

Requirements:

- Must be a high school senior
- Must attend Crowder College during the Fall 2016 semester
- Must major in a business degree at Crowder College (A.A. or A.A.S.) and declare this major prior to the Fall 2016 semester
- Must be a full-time student (minimum 12 hours per semester)
- Must enroll in at least one business class each semester
- Must have and maintain at least a 3.0 grade point average on a 4.0 scale

Renewal Requirements:

- Must major in a business degree at Crowder College (A.A. or A.A.S.)
- Must be a full-time student (minimum 12 hours per semester)
- Must enroll in at least one business class each semester
- Must maintain at least a 3.0 grade point average on a 4.0 scale
- Must complete the renewal form each semester
