OSHA 2055 - Cranes in Construction (\$649)

OSHA 2255 – Principles of Ergonomics (\$649)

Three day course

This course covers the use of ergonomic principles to recognize, evaluate, and control workplace conditions that cause or contribute to musculoskeletal and nerve disorders. Course topics include work physiology, anthropometry, musculoskeletal disorders, use of video display terminals, and risk factors such as vibration, temperature, material handling, repetition, and lifting and patient transfers in health care.

OSHA 2264 – Permit-Required Confined Space Entry (\$649)

Three day course

This course covers the safety and health hazards associated with permit-required confined space entry. Course topics include recognition of confined space hazards, identification of permit and nonpermit required confined spaces, use of instrumentation to evaluate atmospheric hazards, ventilation techniques, development and implementation of a confined space program, proper signage, and training requirements. Three day course

OSHA 5600 - Disaster Site Worker Trainer Course (\$749)
